I. INTRODUCTION

Framework

This Guide for the preparation and submission of applications for advanced computing projects is a document that is intended to clarify aspects of the submission process, to facilitate and guide the preparation of the application and to inform about the evaluation, communication of the decision and prior hearing processes.

It gathers information dispersed through the website of FCT (Foundation for Science and Technology) and RNCA (National Network of Advanced Computing) on the internet, by the application form and by the applicable legislation without, however, overgoing the legislation. It highlights important aspects to which the IR (Responsible Investigator) should pay attention.

At [FCT — Call for Advanced Computing Projects 3rd Edition](#) are published all the announced, open and recent calls on advanced computing projects. This page provides the Call Notice (AAC) and gives access to the regulations and the application submission portals. Who can submit applications

All institutions and candidates complying with the conditions set out in the Regulations and this Call notice. All applicants must have an active CienciaID with up-to-date information. For more help check the CienciaVitae guide and the following page <https://www.cienciavitae.pt/>

Basic advice

- Before starting the application form, please inform yourself of the conditions of access and limits for the allocation of computational resources.
- The schedule of applications A0 and A1 will be available, since for these types of access the call will be open continuously with different rounds. Submissions calendar is publicly available. Only applications received so far will be evaluated in each of these rounds.
- It is strongly advisable to select A0 to all those who do not have experience in the selected software or platform.
- Submit your application as soon as you gather all the necessary information.
- After submission, all A0 and A1 applications will be verified for their technical suitability and A2 applications also by scientific evaluation. Applicants will be notified of the final decision within the deadlines indicated in the Call notice.
 - In the event of approval of the application, applicants will receive an individual report and an acceptance term which they must return signed within the deadlines stipulated in the RPCA. Upon receipt of this document, details will be sent for allocation of computational resources and a single reference of the project. The operational centers will be informed of the approved projects and will provide access credentials to candidates according to their access policies.
 - In case of conditional approval of the application, applicants will receive an individual report and details of the allocation of computational resources, with the conditions described – these may be related to the selected project or platform (temporary unavailability of the machine, software, technical support, just to name a few examples).
 - In the event of non-approval of the application, applicants will be informed. If they so choose, they can make improvements and resubmit their application in the next period or batch of technical suitability.

How to write a good application

- The form will be completed in English.
- All fields marked with asterisk * are required.
- The MyFCT platform has the possibility to "Consult" / "Edit" / "Remove" your application until the end of the contest. If you need to make stops, you can save and come back later.
- Find out more about the available platforms by checking the data sheet in the URL: <https://www.fccn.pt/computacao/rnca/>. This prior consultation will be useful to you as the form is requested the order of preference of the HPC (High Performance Computing) platforms.
- In the "Previous Experience" section of the form, specify any prior experience on the platform(s) to the competition or in others not contemplated by the RNCA (e.g. PRACE). You can indicate previous publications or works.
- For the "Work Plan" in the "Application Data" section you can find templates [here](#).
- Focus on technical requirements as they will have a greater weight in the evaluation. Be clear in the work plan or work plan detailing the various phases of the project, the software to be used, the tasks and especially in the justification of the computer resources requested.
- Identify the software that best applies to your project and find out if it is already installed on the selected platform(s). This information will be updated in the fact sheet of this contest. If you have any questions about the hardware/software version or other technical detail, please contact RNCA via email.

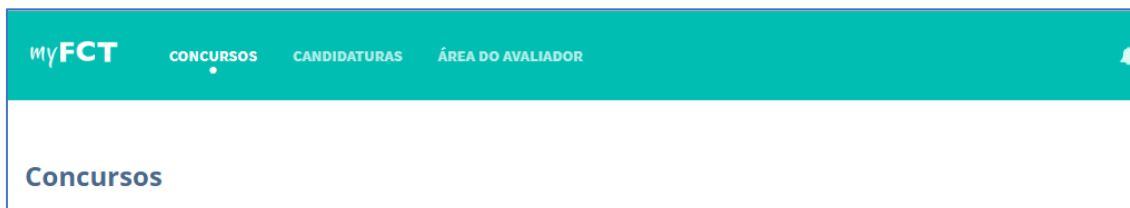

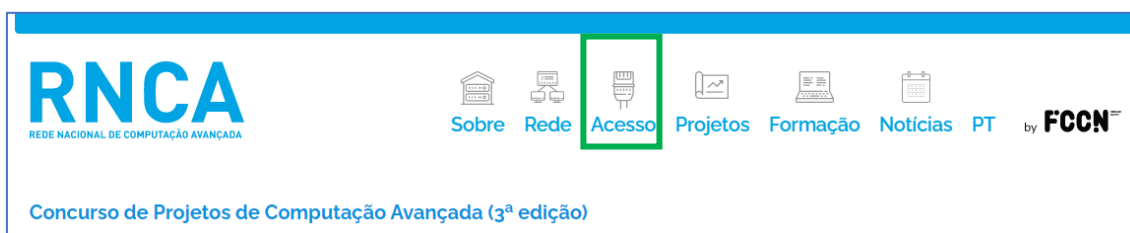

Section 1: IR and Co-IR details

In this section it is intended to obtain the identification of the project manager (IR) and co-responsible (co-IR). The email provided will be the preferred contact for communication and notification of results.

Title* (text up to 255 characters) - Phrase with the title of the project

Abstract* (free text, 0-1500 characters) - *Short Public Abstract* or state of the art of the project, where you can briefly describe the objectives, hypothesis, motivation, need for computational resources and plan for dissemination of results. Previous experience may be described in a proper field at the end of this section. The computational resources will be detailed in section 4 of the form.

Keywords* (text) - Three to five keywords

Work plan * (text 0 to 4000 characters) - This is a fundamental field of the application that will be reviewed at the technical evaluation stage. Subsection: Previous experience

Previous experience (options and description) - answer the question "Have you ever used HPC or HTC platforms or cloud science?" and select one or more options. In the requested description you can summarise the previous experience including dates, software, platform and summary of results obtained. Optionally you can include reference to projects approved by FCT/PRACE/other entities and associated reports.

Select one option. Only answer yes if this scientific or innovation project has been subject to prior independent evaluation by a competent entity. Otherwise, answer "no".

If you choose to edit, please note that the application status will revert to draft, requiring you to resubmit it again after editing.

You can consult your application data at any time in the application area of MyFCT.

For A0 access, in the RNCA submission format, it is not yet possible to view or edit the application status after submission. The final .pdf version of the application will be sent to your email inbox. If you wish to withdraw your application or make minor changes, please contact rnca@fccn.pt. For the evaluation of proposals every 2 months, only the date and time of the last submission will be considered. For each round of applications A0/:

- Each application for A0 access will have a summary administrative and technical validation.

After approval

In case of approval, and the legal deadlines defined, FCT will request the signature of a term of acceptance. Upon receipt of this document, each approved application will be assigned a unique

project reference. Keep it, because in case of request for extension or submission of a new project, this reference will be requested.

Upon completion of each project, applicants will be required to submit a simple final report within 30 days of finishing the work, using the template that is going to be shared later.

Each user must respect the Access Policy of the operating centre that operates the selected platform. We remind you that it is the responsibility of each user to back-up their data during and after the use of the platforms. After finishing the project, the data must be stored in a location to be defined by the IR.
