About **CIÊNCIAVITAE**

CIÊNCIAVITAE is the national curriculum management platform that allows you to create, manage, and disseminate your curriculum quickly and easily.

The main advantages of using this platform are as follows:

Single curriculum: shared among different stakeholders in the national academic-scientific system. The administrative burden on the user and the effort involved in validation/certification tasks by multiple agencies are reduced;

Customizable: the user chooses how, when, and what to share. The "Export curriculum" feature allows you to create multiple versions of the curriculum suitable for different needs: customizable content and various document formats;

Integrated: **CIÊNCIAVITAE** is integrated with various national and international systems, such as ORCID, RCAAP, RENATES, etc. Thus, you can reuse information that you have already placed in these systems/databases to build your CV;

Promotes: promote your curriculum by making it public. Thus, other users will be able to find it through the "Find CVs" feature.

Creation of the CIÊNCIAVITAE Curriculum

CIÊNCIAVITAE is aimed at all individuals, Portuguese or foreign, who participate in the national academic-scientific context.

To create a **CIÊNCIAVITAE**, you need to have a **CIÊNCIA** ID, a unique identifier and authenticator. If you do not yet have a **CIÊNCIA** ID, you can register for one [here](#).

After completing your **CIÊNCIA** ID registration, you will be able to create your **CIÊNCIAVITAE** resume [here](#). On the **CIÊNCIAVITAE** platform page, you will find [Frequently Asked Questions](#) and [Manuals and Tutorials](#) that will assist you in this process.

Using the CIÊNCIAVITAE in FCT Calls on the MyFCT Platform

The association of your CV with the application is done on the MyFCT platform, in the application form. For the MyFCT platform to obtain your **CIÊNCIAVITAE** resume, you will need to confirm FCT's access to your resume in the application form.

Subsequently, you should click on "Obtain CV (**CIÊNCIAVITAE**)". The link to the resume in PDF format will then be made available on the application platform, indicating the date and time of the association. Any changes to your **CIÊNCIAVITAE** CV after the date and time of the association will only be taken into account if you remove the CV (click on "Remove") and make a new association by clicking on "Obtain CV (**CIÊNCIAVITAE**)".

Any **changes to your CIÊNCIAVITAE resume after the date and time of association** will only be considered if you proceed with a **new association** by clicking on "Obtain CV from **CIÊNCIAVITAE**."

Access of the FCT to the CIÊNCIAVITAE

The FCT will access a subset of the data recorded in your CIÊNCIAVITAE. This subset includes information relevant to most of the FCT evaluation processes and complies with the requirements of the new [General Data Protection Regulation](#) (GDPR).

Access via API

CIÊNCIAVITAE provides an API¹ service that enables communication between this platform and other systems.

Accessing your **CIÊNCIAVITAE** via API is possible even if your curriculum is not published on the platform.

Access to "Public" and "Semi-public" Information

The API access credentials provided to the FCT by the **CIÊNCIAVITAE** platform allow this entity to access the information recorded in your CV with the privacy levels of "Public" and "Semi-public".

¹ *Application Programming Interface*: allows data to be transferred between systems.

User privacy is of utmost importance to the **CIÊNCIAVITAE** platform. Therefore, users have the ability to define the privacy level of each record in their CV:



Public:

Accessible to: everyone (includes third-party systems)

This information can be used under a [CC BY \(4.0\) Attribution License](#).



Semi-public:

Accessible to: user

[curriculum managers appointed by the user](#)

third-party systems authorized by the user



Private:

Accessible to: user

When submitting an application to the FCT where the source of curriculum information is your **CIÊNCIAVITAE** resume, according to Article 6(1)(b) of the new GDPR, the FCT's access to the user's resume is lawful. Since the information collected in the context of this application represents pre-contractual diligence required by the user, consent is given when choosing to use **CIÊNCIAVITAE**. Therefore, consent for FCT's access to your CV will not be requested in this application.

Under the protocols established for sharing information between the **CIÊNCIAVITAE** platform and third-party systems, the transmitted information cannot be shared with any other person or entity unless: 1) the information in

question is public in another system, or 2) the third-party system informs the user about what information will be shared and with whom it will be shared.

However, the **CIÊNCIAVITAE** platform is completely unrelated to how third-party systems use the user's information. Therefore, users should be careful in choosing the systems that access their **CIÊNCIAVITAE**.

List of Accessed Data

As previously mentioned, the FCT will access a specific subset of information recorded in your **CIÊNCIAVITAE**.

In accordance with Article 5 of the new GDPR, this subset of information adheres to the following principles:

1. Lawfulness, fairness, and transparency;
2. Purpose limitation;
3. Data minimization;
4. Accuracy;
5. Storage limitation;
6. Integrity and confidentiality.

The accessed data can be consulted through the tool "Export curriculum" available on the **CIÊNCIAVITAE** platform. In the "Privacy Level" parameter, you must choose the option "Public and Semi-public".

Please note that some of the data accessed by the FCT may not be subject to evaluation. The evaluation criteria for the FCT resume are explicitly mentioned in the "**Call Notice**."

Please ensure that all data required by the FCT has the "Public" or "Semi-public" privacy level set. Any information set to "Private" privacy level will not be accessed by the FCT, meaning it will not be available for evaluation.

The **CIÊNCIAVITAE** user is ultimately responsible for managing the privacy levels of records in their **CIÊNCIAVITAE**. The **CIÊNCIAVITAE** platform cannot be held responsible for the outcomes of this management.
